Key Memories Photography Contract

Each type of session must be booked separately and is subject to its outlined fee unless other arrangements have been made. If multiple people/families take part in the same session, one session fee will apply, however time and number of image restraints will also be limited to that of the one booked session.

All digital images will come with a print and share release form which allows you to print the images how you would like (any size and any number of prints) and share them via social media, **with photographer credit**. The photographer (Holly Key) reserves all usage rights to the images in all forms aside from those granted within this print and share release.

Digital images will be delivered via Google Photos, and you will have 14 days from the date of delivery to download them before they will be deleted from Google Photos. If you are unable to use Google Photos, another option for photo delivery can be discussed. Full payment and a signed contract are due at the time of your session and are required before receiving any images. Payment can be made with cash or check. Bounced checks will be subject to a bounced check fee plus the amount of the check.

*Locations more than 30 miles outside of the photographer's working area are subject to an additional fee. Locations that require a permit/fee to photograph in will be subject to an additional fee equal to the cost of obtaining the permit/the cost of the fee. However, there are many nice places that do not require a photography permit, and I will be happy to discuss these options with you.
